### Privacy notice

Croatian Academic and Research Network - CARNET, being a Register of .hr domains, respects privacy and security of its users. Therefore, by the means of this Privacy Notice we wish to inform of personal data we collect, how we use them and how we take care of their protection, as well as to inform you of your data processing rights.

#### Data we collect

The Register of .hr domains collects personal data of the domain users for the purpose of registration and administration of those domains. Those data are not used for any other purposes according to the Article 6, Item 1 b) of the (EU) Regulation 2016/679 of the European Parliament and Council dated April 27<sup>th</sup> 2016 relevant to the protection of the individuals with the regard to the processing of personal data and free movement of such data, as well as repealing the Directive 95/46/EZ (General Data Protection Regulation), (SL L 119, 4.5. 2016.)

During the process of registration of the domain the Register of .hr domains is collecting following personal data; name and surname of the user, address of the user, personal identification number of the user and email address.

All personal data are solely used for the purpose they have been collected for.

#### Period in which the personal data are stored

For the reason of the archival and historical reasons the Register of .hr domain does not delete data on domain users.

## Transfer of your personal data

Personal data of the domain users and persons in charge of the contact with the domain user are not publicly available, but may be transferred to the third person upon request for transfer of the personal data, if there is a legitimate interest. The domain user will be informed by the Register when such data transfer is to be carried out.

### Access and update of your personal data

At any time, our user has the following rights:

Right of access and right of insight to data.

- Right of being informed of personal data processing.
- Right to data transfer.
- Right to withdrawal of consent.
- Right to opposition.
- Right to correct or modify personal data in case when the data are incomplete or incorrect.
- Right to erasure in cases when there is cessation of the purpose of processing, withdrawal of consent or in case of opposition.

#### Personal data security

We undertake all technical and organizational security measures in order to protect your personal data from unauthorised or unlawful handling and from its accidental loss, destruction or alterations.

### Identity and contact details of the Data Protection Officer

Relevant to the valid regulations CARNET has appointed a Data Protection Officer which can be contacted for all matters related to the processing of your data or to exercise your rights for protection of personal data in CARNET.
